3. Supervising the Board of General Directors by the Board of Directors:

In the first six months of 2025, the Board of Directors successfully fulfilled its supervisory role and functions in accordance with the Law on Enterprises, the Company's Charter, and the current internal corporate governance regulations. The BOD seriously and fully carried out its responsibilities in supervising the management activities of the Board of General Directors to ensure that the Company's business operations were conducted in line with its strategic direction, efficiently, transparently, and in compliance with the law.

Specifically, the BOD exercised its supervision through:

- Issuing and monitoring the implementation of the BOD's Resolutions, Decisions, and management directives, thereby ensuring that the Board of General Directors carried out activities in accordance with the content, schedule, and objectives set by the BOD and the General Meeting of Shareholders.
- Reviewing regular reports from the Board of General Directors, including business performance reports, financial reports, investment activities, and operations of subsidiaries, enabling the BOD to provide timely feedback and necessary guidance.
- Monitoring compliance with internal regulations to ensure that corporate governance activities are conducted in line with best practices and suited to the organizational model of a public company.
- Assessing the efficiency and transparency of the management activities to ensure that decisions made by the Board of General Directors are based on sufficient information, with consideration of risks and long-term benefits for shareholders, employees, and other stakeholders.

Through these activities, the BOD effectively fulfilled its roles of orientation, supervision, and support to the Board of General Directors, ensuring the Company's operations remained continuous, stable, and responsive to market fluctuations amid a challenging business environment in the first half of 2025.
