3. Supervisory activities of the BOD over the Board of Management:

In the first half of 2026, the Board of Directors fully performed its supervisory functions in accordance with the Law on Enterprises, Company's Charter, BOD's Operational Regulations, and relevant internal regulations. The supervisory activities were conducted regularly to ensure the Board of Management's operations complied with the Resolutions of the General Meeting of Shareholders, the Board of Directors, and legal regulations.

The Board of Directors conducted its supervisory activities focusing on the following key areas:

- Supervising the implementation of Resolutions and Decisions of the Board of Directors and the General Meeting of Shareholders; promptly reviewing and providing opinions on matters within its authority to ensure the progress and effectiveness of the tasks and targets for 2026.

- Monitoring and evaluating the management activities of the Board of Management through periodic reports and reports on business operations, finance, investment, risk management, safety, digital transformation, and other management areas; based on this, directing and orienting appropriate solutions in line with market developments.

- Supervising compliance with legal regulations, the Company's Charter, internal governance regulations, and internal management regulations; ensuring corporate governance is conducted transparently, effectively, and in accordance with regulations.

- Supervision of the implementation of investment programs and projects, cost management, resource management, and the effective utilization of existing facilities; concurrently monitoring the implementation of solutions to enhance business efficiency as directed by the Board of Directors.

- Regularly assess market conditions, identify risk factors that may affect the Company's operations to promptly direct the Board of Management to implement responsive measures, ensuring safe, continuous, and efficient business operations.

Through supervisory activities, the Board of Directors assessed that the Board of Management has been proactive and flexible in management, seriously implementing the Resolutions of the Board of Directors and the General Meeting of Shareholders; while continuing to maintain effective business operations, ensuring operational safety and enhancing corporate governance efficiency.

4. Activities of the Board of Directors' subcommittees:

According to the provisions of Circular No. 116/2020/TT-BTC dated December 31, 2020, issued by the Ministry of Finance guiding certain provisions on corporate governance applicable to public companies under Decree No. 155/2020/ND-CP dated December 31, 2020, the Company's Charter, and the internal regulations on corporate governance, the establishment of committees under the Board of Directors is not mandatory.
